We are committed to confidentiality and objectivity in all of our services. In the case of activities as a measuring, testing, monitoring, certification or verification body or testing laboratory, we also commit ourselves to impartiality, and are aware of the great importance of this.

To avoid conflicts of interest, products of the type that we certify are neither manufactured, supplied nor developed by our certification bodies. Customers whose products or management systems are certified by us or whose CO₂ emission reports are verified by us are not offered services such as for example advice in connection with these products / systems / topics or internal audits that call our impartiality into question.

Environmental protection, occupational safety and health protection
